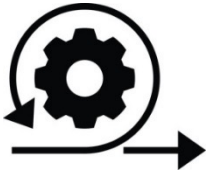

## How do I make payment?

- Candidates who do not pass the exam may retake the exam two more times for a total of three times within one year of application approval. There will be fees imposed.

## What are the requirements to sit for a PMI ACP® exam?

- Secondary degree
  - 21 contact hours of training in agile practices
  - 12 months of general project experience within the last 5 years. A current PMP® or PgMP® will satisfy this requirement but is not required to apply for the PMI-ACP®.
  - 8 months of agile project experience within the last 3 years
